

Dear Sir/Madam:



This Letter of Authorization is issued in lieu of a Certificate of Registration and is valid only when payment is tendered with an official check or credit card bearing the organization's name. The authorization is not considered valid for any purchase to be used in the operation of the organization or school.

One copy of this Letter of Authorization must be furnished to each supplier of resale property in order to relieve the dealer from collection of the tax. *This Letter of Authorization does not require the use of a sales and use tax registration number, does not expire, and will remain valid as long as the organization continues to meet the exemption requirements provided by O.C.G.A. § 48-8-3(56).*
